

Bursary for Driver's Education Program

This Children's Aid Foundation Bursary has been developed to assist youth with Child in Extended Society Care (Crown Ward) status and young adults who previously had Child in Extended Society Care status with The Children's Aid Society of the District of Thunder Bay, to achieve independence skills and career goals.

The bursary is offered to young people who wish to obtain a driver's license and complete a Driver's Education Program.

This bursary will provide up to seven hundred fifty dollars (\$750.00) towards the cost of a Driver's Education Program.

The bursary recipient(s) will be selected by the Children's Aid Foundation Bursary Committee. If selected to receive the bursary, the applicant must complete a driver's education course by December 31, 2019.

Eligibility

This bursary is available to:

- Persons who have Child in Extended Society Care status, or who had Child in Extended Society Care status with The Children's Aid Society of the District of Thunder Bay on their 18th birthday and are currently on a Continued Care and Support to Youth Agreement (CCSY); and
- Are now 16 years of age or older.

What to Include in the Application

- Application Form
Please complete the attached Application Form.
- Letter of Reference
A reference from the applicant's CAS worker or former worker, or another suitable adult, stating why they feel the youth (applicant) should be awarded this bursary. The reference must demonstrate that the youth (applicant) is achieving to the best of their ability.
