

Message from the President & the Executive Director

The Annual meeting report is a time to remember the good times, and a time to reflect on the challenges faced this past year.

The Children's Aid Society of the District of Thunder Bay has a special bond with families and children throughout our community and we are proud of the work done by those associated with the agency who help build that bond.

Our children in care continue to be a source of tremendous pride. The resilience and determination that they demonstrate is quite remarkable and very inspiring. Whether the achievement is an academic award, athletic excellence, or other worthy skills, young people are excellent reminders of the importance of the work we do. We take heart from the child in care who in her early years struggled against herself and her workers and now is so confident that she can educate others. The process to understand her needs was a long one which involved many advocates both within and outside the agency. The path was challenging and we are proud of the bright and articulate young woman who emerged.

Her accomplishment illustrates the potential that exists in all of our children in care. It demonstrates that if supported in the long term, young people will blossom into thoughtful and responsible young adults. The wait may sometimes be long but with consistent and patient support provided by many people in the circle of support, the spirit of our young people rises to the top.

The foundation of those success stories is the foster parents. They are the supports and advocates of our children. Some of our caregivers have different ideas than we do on how the task needs to be accomplished and the timeframe for doing it. At times the discussions become vocal when the opinions differ on what to do and how to help. But these disputes are important because in these moments we understand how much all parties care and how committed they are to helping a child grow. The key theme is we keep trying, we keep moving forward with the Vision that we can create a community where all children grow up with a sense of belonging, in a safe and nurturing environment. Foster parents are integral to the agency reaching for our Vision, their caring and compassion create opportunities for children and youth.

Our agency continues to be a provincial leader in providing care in agency foster homes. Throughout the province many agencies purchase service for children from for profit organizations. Our service model speaks to the hard work of the staff who identify, train and support foster parents. It is also a testament to the agency's beliefs and our Foster Family Association for their continued commitment to children and families. An excellent example of the level of commitment by our foster families is illustrated by the story of a 12 year old girl who moves into a foster home. She goes on to graduate from university some 10 years later. She moves through the difficult and challenging years of adolescence adapting to life in foster care, a feat of no small proportion made easier by the support of her foster family. Ultimately she graduates to become a bright young professional in the community who will be a resource and inspiration to others. The foster family, of course, attends the graduation of their foster daughter and after the ceremonies involves the birth family in a celebration of their child's success. The ultimate goal of the agency is to provide safe and nurturing environments for children and this is an inspiring example of that commitment.

The files of the Children's Aid Society are filled with many such similar stories. Despite the many successes, we understand that the work we do is powerful and it impacts people in different ways. We understand that there are different points of view and respect those different opinions. However, we strive to provide our service in a manner which exemplifies our commitment to treat all people with respect.

Such treatment is not possible without the continued professionalism of managers and staff who work with diminishing community resources to meet the needs of our consumers. Despite the best efforts of our community partners, waiting lists continue to grow and services are in short supply. We thank community service partners for their continued work to make more out of less.

We thank our funders. However, the ongoing need of our funders to demonstrate accountability has lead to a seemingly endless demand for paperwork. The balance between accountability and sustainability continues to be a source of concern, it is a challenge that staff face on a daily basis. The consequence of this dilemma is less time with children and families. We respect the needs of our funders, but look forward to the continued discussion on how to meet both the needs of the taxpayers who ultimately provide funds for child protection and the service providers who strive to meet the growing demands for services.

Oversight of the agency is done by a group of voluntary Board members, a determined group of community members who provide the agency with wisdom and support. Their role is not an easy one as they ultimately are responsible to balance resources and needs.

As is the case each and every year the successes outweigh the concerns and the agency continues to strive to "protect and enhance the lives of children through strengthening families in partnership with our community".

On behalf of everyone at The Children's Aid Society of the District of Thunder Bay, we wish you a very safe and happy summer.
