POSITION PURPOSE:

Reporting to the Executive Director, the Director of Resources & Children's Services is a member of the Society's Senior Management Team responsible for the efficient and effective delivery of Society services relating to Children in Care, Foster, Adoption and agency support programs.

The Director of Resources & Children's Services will coordinate the work of the Service Managers and ensure that the duties and responsibilities of the staff in these positions are fulfilled within the Society's policies and procedures, the legal framework of the CYFSA, and in compliance with Ministry Regulations and Standards. The Director of Resources & Children's Services will also plan and implement program initiatives to meet service benchmarks that will ensure the protection of children, which are aligned with the Society's Vision, Mission and Values Statements.

POSITION QUALIFICATIONS AND REQUIREMENTS:

- M.S.W from an accredited school of social work and a minimum of five years progressively responsible management experience in child welfare.
- Enabling competencies of this position that are required would include:
