Child and Youth Workers – Day Shift Availability Casual Relief and One-On-One Care

Shift Relief: Child & Youth Workers who are available to work various shifts on a casual basis, in our adolescent group home and/or our therapeutic day treatment program. Shifts (Group Home: 7:00 am to 7:00 pm and 7:00 pm to 7:00 am; Day Treatment Program: 8:30 am – 4:30 pm) are scheduled with as much notice as possible, with worker availability taken into consideration.

Currently, preference will be given to those applicants who are available to accept weekday shifts.

One-on-One Care: The Child & Youth Worker is assigned to support a youth through individual work in the community focusing on life skills, recreation or other. 5 hour shifts, once or twice a week. Access to a personal vehicle is required for this work assignment.

Compensation: \$18.00 per hour.

Position Requirements

- Child and Youth Worker Diploma or Degree, or current enrollment in a C&YW program; individuals with a human services diploma or degree, and experience in a youth residential setting, may be considered
- Experience in residential care work and high needs youth and children
- Knowledge base regarding: Adolescent development, family dynamics, parenting and child care principles, crisis management, conflict resolution, therapeutic programming and residential treatment
- Demonstrated ability to work collaboratively within multi-disciplinary teams
- Excellent communication, documentation, organizational, and time management skills
Demonstrated knowledge, skills and abilities to work effectively with diverse communities
- For all work assignments:
 - Valid "G" Driver's License and safe driving record (no more than 2 driving offences in the last 3 years and/or no more than 5 demerit points)
 - Upon hire: Receipt of Current Criminal Records Check (Vulnerable Sector) and Child Welfare Check both deemed satisfactory to the employer
- For residential shifts only:
 - Upon hire: Current Standard First Aid Certificate and PMAB Certificate (or willingness and ability to obtain); and medical clearance certificate satisfactory to the employer
- For one-on-one assignments only:
 - Access to a reliable vehicle suitable to transport youth
